

CONGRESS MOVES TO 2021



The coronavirus has had an effect on every aspect of our lives, and it turns out it's also had an effect on the Pacific Logging Congress.

The Executive Board decided that due, to restricted travel budgets, overall concern about travel and the potential of a COVID resurgence in the Fall, it was best to move the 2020 convention to 2021. This means that all subsequent annual events will be moved as well — Arizona 2022, Live In-woods Show, 2023, etc.

The convention will still be held at the Hyatt in Indian Wells, California, with Wayne Settle as PCL president. More details will be available on the PLC website as the event draws closer.

And as always, the money will go to the PFF educational programs and scholarships.


As details and items come together, they will be posted on the PLC website, but currently just a few of the exciting live virtual auction items include:

RRLC Conference canceled — but Pieces Remained

The 82nd Annual Redwood Region Logging Conference (RRLC) in California, which had been scheduled to take place March 19 -21, 2020, is just one of the many large gatherings canceled due to the COVID-19 pandemic. This year's event was planned to take place in Ukiah in Mendocino County.

RRLC Executive Director Katherine Ziemer said the Board of Directors held a conference call one week before the conference was slated to begin. "The Board discussed our options," she said, "and voted to suspend the conference due to the health risks. No one took this lightly when the Board voted to cancel the conference," she added, "and this was definitely the right choice."

No date has been selected for the RRLC next year, and it is possible that the event will take place in Ukiah, even though the conference normally rotates every other year between Ukiah and Eureka. That decision will be discussed and then announced by the RRLC Board of Directors later this year. "We are experiencing unprecedented times and we need to be resilient," Ziemer said. "We plan to rebound next year even stronger."



Two pieces of RRLC were able to continue, even though the conference gathering had been canceled.

"The scholarship students had already been judged prior to the cancellation and their awards were mailed to each student," Ziemer said. "The mural contest was able to continue," she added, "because teachers delivered the murals on Friday, March 13th, before the conference was canceled."

13 scholarships, totaling \$17,000 were awarded to students attending colleges in California and Oregon. Seven were awarded to students attending Humboldt State University. They were Marcos Saucedo, Cameron Miller, Wiyaka Previtte, Brita Goldstein, Kyle Mantzouranis, Hanna Upton, and Christopher Villaruel. Isaac Lang,

a student attending College of the Redwoods, also received a scholarship.

Other recipients were Dustin Morgan and Taylor Plasch, both students at Cal Poly, San Luis Obispo; Emma Miller who is attending Chico State; Natalie Fulton, a student at U.C. Berkeley; and Natalie Schlosser who is attending Oregon State University.

Schools in both Humboldt and Mendocino Counties submitted murals to the RRLC. The submitted murals were judged in two age categories, Kindergarten through 3rd grade, and 4th grade through 8th grade.

Humboldt County winners in the Kindergarten through 3rd grade levels were students from South Fortuna, Jacoby Creek, and Hoopa Valley Elementary Schools. Winners in the 4th grade through 8th grade levels were students from Whitethorn, Morris, and Hydesville Elementary Schools.

Mendocino County murals have not yet been judged, so there are no winners to announce at this time.





Talking Timber Podcast Gets Traction

This past January, the Pacific Forest Foundation launched the Pacific Forest Foundation podcast, Talking Timber, taking listeners behind the scenes of the Northwest Timber Industry.

Over 62 million people listen to podcasts weekly, and it was the PLC's thought that a podcast would allow the PLC to reach a larger and younger audience.
